And Relinquish its Certificate to Provide Local Telecommunications Services**

CTI Fiber Services, LLC ("CTI Fiber" or "Company") hereby submits this Notice of Intent to Discontinue Local Telecommunications Service in Florida effective on or after August 6, 2020. II. BACKGROUND

CTI Fiber was issued a certificate to provide local telecommunications services in Florida in Docket No. 20190052-TX on June 24, 2019. The Company has not provided any local telecommunications services and has no customers in Florida. The Company no longer intends to provide local telecommunications services and hereby relinquishes its certificate of authority effective August 6, 2020, or at the earliest practical date.

III. REASON FOR DISCONTINUANCE AND CUSTOMER IMPACT

CTI Fiber has changed its business plan and no longer intends to offer telecommunications services. Since the Company has never offered any such services, its discontinuance will not impact any customers. The Company does not hold any customer deposits and has received no advance payments.

IV. NOTICE

CTI Fiber does not offer customer notice in support of this notification because the Company has not offered services to any customer to date. Under Section 63.71(g) of Title 47 of the Code of Federal Regulations, the Company is also exempt from submitting a discontinuance filing to the Federal Communications Commission because it has had no customers or requests for telecommunications services during the preceding thirty (30) day period.¹

¹See 47 C.F.R. § 63.71(g) ("Notwithstanding any other provision of this section, a carrier is not required to file an application to discontinue, reduce, or impair a service for which the requesting carrier has had no customers or reasonable requests for service during the 30-day period immediately preceding the discontinuance.").
