I understand the Public Service Commission is having a hearing On Thursday to discuss Net-Metering of Solar here in Florida. Is there a way to attend this hearing remotely vs having to travel to Tallahassee? I have powered my home in Ocala since a July 2007 before we had net-metering in October 2008 and I do not want to see any changes that would negatively affect the current net-metering rules.

Changes to the net-metering rate that would negatively affect Florida homes and businesses from investing in solar power would be a mistake. I owned my solar system for over a year before the PSC finalized and passed the current net-metering rules. The fact that I was paid less for the power I provided to my utility than what I was required to pay the utility for power I purchased from them was totally unfair.

The current net-metering rules that the 4 public utilities in Florida have should be expanded to ALL FLORIDA UTILITIES. I have a neighbor who also went solar who lives across the road from me who has net metering through their utility. Their non public utilities net-metering rules does not pay them the same way the public utilities pay. Their net-metering with their utility Sumpter Electric Coop (SECO) vs mine Duke Energy are less than equitable payment for their excess production and unfair.

ALL UTILITIES IN FLORIDA SHOULD OFFER FULL NET-METERING JUST LIKE THE PUBLIC UTILITIES.

Homeowners and business in Florida invest their own capital in solar power plants should be rewarded and encouraged. Net-metering is essential to the continued growth of solar here in Florida.

I am also seeing a trend with utilities constantly raising their base monthly charge on their bills. My neighbor who went solar about the same time as me has seen their based monthly charge go from \$9.50/mo to \$14.50/mo then \$20/mo. Next the utility snuck in another based charge increase by going to 83¢ /day charge or almost \$25/mo.....then soon after that they changed it to \$1.00 per day or \$30 or \$31 per month. Duke has also started quietly raising their base customer charge but not as aggressively as my neighbor who has SECO.

In addition to net metering somehow Florida should encourage solar homeowners to also add batteries to their solar systems. This could help grid stability and provide solar homes with power during possible outages during hurricanes or other grid issues.

I would like someone to reply to this email and let me know how I can attend this hearing. If I can't do it remotely then I may try to take off work and drive up Tallahassee for the meeting in person. If I come in person I will bring several other solar homeowners I know up with me.
