Dear Chairman Gary F. Clark,

Time and time again, Florida's voters have made their support for policies meant to encourage the spread of rooftop solar clear. In 2016 voters rejected the utility-driven "Amendment 1", which would have prohibited the subsidization of solar energy, and approved 'Amendment 4', which provided tax exemptions for rooftop solar customers.

Florida is in the middle of a public health and economic crisis. Undermining the rights of solar customers to receive full compensation for the power they produce will hurt jobs and take money out of people's pockets.
