Dear Florida PSC Commissioners,

Florida citizens and customers overwhelmingly support the current successful net metering policy allowing compensation for the solar energy they generate and provide to the electricity grid.

Please protect the opportunity for business and homeowners to generate clean solar power and support local jobs by preserving our successful net metering rules here in Florida.

I am a prior FPL employee. I know that Domestic power production can significantly reduce the need for future power plants.
