PUBLIC SERVICE COMMISSION

The FLORIDA PUBLIC SERVICE COMMISSION announces a hearing in the following docket to which all persons are invited.

DOCKET NO. AND TITLE:20200092-EI, Storm protection plan cost recovery clause.

HEARING DATE AND TIME: Tuesday, October 6, 2020, starting immediately after the Commission's Agenda Conference, which is scheduled to commence at 9:30 a.m. on that date.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purpose of this hearing shall be to consider the Joint Motion of the Office of Public Counsel, Florida Power & Light Company, Gulf Power Company, and Walmart Inc. for expedited approval of a stipulation and settlement agreement and to take action on any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions or matters from the bench or may take them under advisement. This proceeding shall: (1) allow the parties to present evidence and testimony in support of their positions; and (2) allow for such other purposes as the Commission may deem appropriate.

This proceeding will be governed by Chapter 366 in addition to Chapter 120, F.S., Chapters 25-22, 28-106, and 28-109, F.A.C., and Rule 25-6.030, F.A.C.
