Thank you for expressing your concerns regarding the quality of service provided by your utility. To ensure that the Commission staff and the Commissioners have knowledge of your concerns, your letter has been placed on the correspondence side of the docket file.

In evaluating the utility's request for a rate increase, staff investigates the utility's current compliance with the Florida Department of Environmental Protection's secondary standards and other quality of service items. Secondary standards regulate contaminants that may impact the taste, odor, and color of drinking water. When investigating a utility's compliance status and quality of service, Commission staff reviews documents on file with the Florida Department of Environmental Protection and customer complaints and comments. After we complete our analysis, a recommendation is prepared and presented to the Commission regarding the utility's requested rate increase. We filed this recommendation on September 24, 2020. The recommendation is available for your review on the Commission's website at [www.floridapsc.com](http://www.floridapsc.com) in Docket No. 20200152-WS. The Commissioners are scheduled to vote on staff's recommendation on October 6, 2020.
