Dear Mr. Fogleman:

Global Strategic Accountants (GSA) are consultants for WhiteSky Communications (“WhiteSky”), a VoIP provider located in Alabama. We handle regulatory and tax compliance along with other telecommunications related matters for WhiteSky.

Pursuant to the Federal Communications Commission’s (FCC) 15-70 Order¹, allowing interconnected VoIP providers to obtain resources directly from the North American Numbering Plan Administrator and/or the Pooling Administrator, we hereby notify the Commission of our receipt of FCC numbering authorization².

In compliance with Federal rules WhiteSky Communications hereby notifies this Commission of its intent to request the resources identified below. We are providing this notice at least 30 days prior to requesting numbers from the Numbering Administrators³.


