Details:

Utilities Inc of Florida has recently filed for a rate increase that would allow it to increase its return on equity to 11%. This is an exceedingly high percentage for a public utility. This would increase rates on the average homeowner by \$20 a month. This is an additional increase of 25% in the total water bill after we have already had a 100% increase in the last several years because of the purchase by Utilities Inc. of Florida of our prior local water utility. Enough is enough for increases to the consumer by a utility owned by a non-US parent company.
