Good Afternoon,

My name is Barb Dwyer. I am a full-time resident of Little Gasparilla Island living at Hideaway Bay Beach Club Condos - Unit G8.

I would like to request that I be considered an interested person regarding the following docket:

Docket Number 20200226-WS, Application for certificate to provide wastewater service in Charlotte County by Environmental Utilities, LLC.

I have the following concerns:

1. Little Gasparilla Island & the surrounding areas are environmentally sensitive and would benefit from wastewater service to prevent the runoff of Nitrogen & Fecal bacteria from aging, overburdened septic systems.
2. Charlotte County put together a comprehensive Sewer Master Plan dated 2017 for bringing wastewater service to LGI, Don Pedro, Knight Island, Cape Haze. Environmental Utilities, LLC (EU) is not planning on following the recommendations of said Sewer Master Plan.

3. Historically, any kind of work being done on the island costs 2 - 3 times more than the same job on the mainland. Add on the profit margin for a For Profit Utility and the cost to each resident could be astronomical. Residents could end up paying an impact fee anywhere from \$20,000 - \$40,000.
4. There was no mention of the 2 condo associations within the scope of the agreement EU signed with Charlotte County. We are within the target area. We have our infrastructure in place. Provisions should be included for bulk customers at the onset of the planning process.
5. I am a single taxpayer living alone. My water utility bill averages out to be ~\$100 a month - run by Jack Boyer's LGI Water Utility Company. My power utility bill averages out to be ~\$65 per month with a \$9 contribution to solar energy each month. I find it curious that my water bill is so much higher than my power bill. I am scared to think about what my sewer bill will look like!
6. Bifurcation of the plan from the costs is not in the best interest of the residents.
