We represent Walmart Inc. ("Walmart"), an interested party in the above-referenced docket. Walmart appreciates the opportunity to provide comments and respectfully requests that the Florida Public Service Commission ("PSC" or "Commission") accept these Written Comments on behalf of Walmart.

Walmart appreciates the effort by Florida Power & Light Company ("FPL") to develop an electric vehicle public charging pilot tariff. Walmart reviewed Written Comments filed on November 30, 2020, by EVgo Services, Inc. ("EVgo") and by Tesla, Inc. ("Tesla"). For reasons set forth in EVgo's and Tesla's Comments, Walmart supports the following modifications to Staff's recommendation in favor of FPL's pilot tariff:

1. EVgo's and Tesla's proposal to increase the demand limiter to more than the proposed 75 hours;
2. EVgo's proposal to apply the demand limiter to both new and existing stations; and
3. Tesla's proposal to have an annual reporting and review process.
