NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION**

Pursuant to Florida Administrative Code (“F.A.C.”) Rule 25-22.006(3)(a), Florida Power & Light Company (“FPL”) hereby files this Notice of Intent to Request Confidential Classification (“Notice”). This Notice relates to confidential information which the Office of Public Counsel (“OPC”) has advised will be included within its direct testimony and exhibits to be filed today, December 8, 2020. Based upon communications with OPC, FPL reasonably anticipates that information contained in the direct testimony and exhibits of OPC’s witness(es) will include confidential information protected from public disclosure by Florida law, including but not limited to Rule 25-22.006, F.A.C., and Section 366.093, Florida Statutes. Pursuant to Rule 25-22.006(3)(a) and (d), F.A.C., FPL requests confidential handling of the direct testimony and exhibits of OPC’s witness(es). FPL will file its Request for Confidential Classification specifying those portions of the direct testimony and exhibits which FPL asserts is entitled to confidential treatment within 21 days, as provided by Rule 25-22.006, F.A.C.
