2. This anticipated increase will present an undue hardship and impose a substantial economic burden to the residents of Utility Inc.'s service area in Seminole County.
3. The FPSC should reject any permanent increase in the cost of water for at least one year from February 4, 2021.
4. By February 4, 2022, the FPSC should conduct – or cause to be conducted – a study to determine whether any increase in the cost of water in the petition area is reasonable based on the study and, if so, to further determine what may be a reasonable increase in the cost of water; and
5.
