DECLARATION OF CHRISTOPHER T. WRIGHT

1. My name is Christopher T. Wright. I am employed by Florida Power & Light Company (“FPL”) as Senior Attorney - Regulatory. My business address and telephone numbers are as follows:

2. I have personal knowledge of the matters stated in this Affidavit.

3. I am an attorney admitted to practice law and in good standing in the State of Pennsylvania since 2006. From 2008 to 2018, I represented natural gas, electric, and water utility clients in state regulatory proceedings before the Pennsylvania Public Utility Commission and Pennsylvania appellate courts. My work included the litigation of a wide-variety of regulatory matters, including rate proceedings, mergers and acquisitions, energy procurement, renewable energy and net metering matters, a variety of consumer complaint cases, regulatory audits and investigations, right-to-know law cases, and other matters before state regulatory agencies and appellate courts.

4. I was approved as a qualified representative and authorized to represent the interests of FPL by Order No. PSC-2018-0402-FOF-OT issued August 14, 2018. Since that time, I have served as Florida Authorized House Counsel and represented FPL before the Florida Public Service Commission, which has jurisdiction with respect to electric and other utilities in the State

of Florida. My work includes representing FPL in general rate proceedings, storm cost recovery proceedings, generating plant need determinations, petitions for financing authority, rulemakings, and other electric utility matters.

I have experience and am familiar with the Florida Statutes relating to the jurisdiction of the Florida Public Service Commission, and the Florida Rules of Civil Procedure relating to discovery in an administrative proceeding. I also have experience and am familiar with portions of the Florida Administrative Code and Florida Statutes relative to the rules of evidence.

6. I have been certified by the Supreme Court of Florida as “Authorized House Counsel” pursuant to Chapter 17 of the Rules Regulating the Florida Bar. Accordingly, I am subject to the Rules Regulating the Florida Bar and to the jurisdiction of the Supreme Court of Florida for disciplinary purposes.

7. I have reviewed Rule 28-106.107 of the Florida Administrative Code and agree to abide by its standards.

8. Consistent with the standard set forth in Rule 28-106.107, I have acquired or will acquire knowledge of the factual and legal issues involved insofar as my representation of FPL is concerned in proceedings before this Commission.
