RE: Administrative Closure of Docket No. 20210039-WS - Application for original water and wastewater certificates for existing utility currently charging for service in Collier County, application for pass through of regulatory assessment fees, and application for original certificate of authorization for existing utility currently charging for service, by Collier Utility Company.

On February 12, 2021, Collier Utility Company (Collier or Utility) filed its application for approval of certificates and a pass-through of regulatory assessment fees. Subsequently, Docket No. 20210039-WS was established. On February 15, 2021, the Utility filed a letter withdrawing its application and requesting a refund of its filing fee of \$2,250. The Utility stated that it inadvertently filed its application and became aware that the Commission does not have jurisdiction in Collier County after filing.

This docket was erroneously opened by the Utility. Therefore, pursuant to Section 2.07 C.2.d(1), of the Administrative Procedures Manual, staff requests that Docket No. 20210039-WS be administratively closed and the Utility's filing fee of \$2,250 be refunded.
