 - > Real Estate: a 3% minimum mandatory charge is imposed on April 1st and an advertising charge is added during April. Tax certificates will be sold on all unpaid accounts on or before June 1st resulting in additional charges.
 - > Tangible Personal Property Taxes: interest accrues at 1 1/2% per month plus advertising and fees. Tax warrants will be issued on all unpaid personal property taxes.
- Penalties are determined by date of receipt if the postmark indicates your payment was mailed on or after April 1st (delinquent date). The amount due is determined by the date your payment is RECEIVED by the Tax Collector.
- If paying by mail, please keep the top portion of this bill along with your cancelled check. Please note your taxes are not "paid" until your check clears the bank.
