- ❖ If this bill is for **real estate** which you have sold, please send this notice to the new owners or return it to the Property Appraiser's Office immediately. If this bill is for **tangible personal property** which you have sold, but you were the owner on January 1 of the tax year, you are responsible for the tax.
- ❖ Please **verify the description** of the property. If any errors in the description are found, immediately notify the Property Appraiser at (407) 665-7506.
- ❖ This notice covers taxes for the calendar year, January 1 through December 31 of the year indicated on the front. The exception to this is non-ad valorem assessments which are paid generally in advance.
- ❖ **Discounts** for early payment have already been calculated at the bottom of this notice. Please pay only one amount. Discounts are determined by the postmark of your payment.
Discounts: 4% - November 3% - December 2% - January 1% - February
- ❖ Taxes and assessments are **due November 1st** and become **delinquent April 1st**, at which time the law imposes the following penalties:
 - **Real Estate:** a 3% minimum mandatory charge is imposed on April 1st and an advertising charge is added during April. Tax certificates will be sold on all unpaid accounts on or before June 1st resulting in additional charges.
 - **Tangible Personal Property Taxes:** interest accrues at 1 1/2% per month plus advertising and fees. Tax warrants will be issued on all unpaid personal property taxes.
- ❖ **Penalties** are determined by date of receipt if the postmark indicates your payment was mailed on or after April 1st (delinquent date). The amount due is determined by the date your payment is **RECEIVED** by the Tax Collector.
- ❖ If **paying by mail**, please keep the top portion of this bill along with your cancelled check. Please note your taxes are not "paid" until your check clears the bank.
