- Issue 8: What is the reasonable and prudent amount of storm related costs that should be capitalized?
- Issue 9: Should the Commission approve St. Joe's proposed tariff and associated charge as filed with Hurricane Michael? If not, should St. Joe be required to file tariffs and charges in conformance with the Commission determination in this matter?
- Issue 10: If applicable, how should any under-recovery or over-recovery collected from the Hurricane Michael charge be handled?
