



NOTICE IS HEREBY GIVEN on this 16th day of April 2021, pursuant to Section 367.045 Florida Statutes, and Section 25-30.036(2), Florida Administrative Code, of the of the Application of South Sumter Utility Company, LLC, for amendment of its Certificates of Authorization to add territory in Sumter County, Florida. These areas consist primarily of former right-of-way parcels, in otherwise undeveloped areas. The proposed territory consists of 8 parcels of undeveloped land located between Florida's Turnpike, County Road 44, and Lake Okahumpka in the northern part of the territory, and near County Road 470W and Lake Denham in the southern part of the territory. The Utility is not requesting any changes to its rates, classifications, charges, rules or regulations in this application.
