Dear Mr. Rendell:

Staff has completed its review and has determined that Brendenwood Waterworks Inc. (Brendenwood or utility) is eligible for the staff-assisted rate case (SARC). The Commission's Division of Engineering has determined the filing fee in this case is \$1,000. The filing fee is based on the capacity of the utility's systems as provided by Section 367.145(2), Florida Statutes (F.S.). The Commission received the Utility's payment of \$500. The balance of the filing fee is due by May 14, 2021, which is the official filing date for this rate case.

Please forward a copy of Brendenwood's application for a SARC to the Chief Executive Officer of Lake County. This is required by Section 367.091(2), F.S., which states:

Upon filing an application for new rates, the utility shall mail a copy of the application to the Chief Executive Officer of the governing body of each county within the service area included in the rate request. The governing body may petition the Commission for leave to intervene in the rate change proceeding and the Commission shall grant intervener status to any governing body that files a petition.

Please file an affidavit stating that this requirement has been fulfilled. The affidavit should be sent to the address below. Please include the docket number (20210155-WU).
