\$500 is for a 1<sup>st</sup> time non-compliance penalty. Of this \$500, \$200 should go to the PSC trust fund and \$300 should go to the General Revenue Fund.

Good afternoon,

This email is a follow up to our phone conversation this morning regarding Reddot Network, Inc. (TY110), and the 1<sup>st</sup> time non-compliance violation docket (Docket No. 20210075-TX) that has been opened due to non-payment of 2020 Regulatory Assessment Fees (RAFs).

As we discussed this morning our Agency received a payment along with a RAF form from Reddot Network on May 17, 2021. The RAFs calculated on the form, and the payment received were \$132.20; however, the minimum RAF due for your certificate is \$600. Because the RAFs were not filed and paid by the February 1, 2021 due date, penalties and interest have been accruing. Currently, the company owes \$611.80 for RAFs and P&I. Please see the calculation below for more details

\$600 - RAFs Due based on revenues reported by company on RAF form  
\$120 Penalty for late file/payment (\$600 x 5% per month x 4 months)  
\$24 Interest for late file/payment (\$600 x 1% per month x 4 months)  
\$744 - 132.20 = \$611.80 Balance remaining for 2020 RAFs and P&I

In addition to the outstanding RAFs, the company has been assessed a \$500 fee for a first time violation of Rule 25-4.0161, Florida Administrative Code, Telecommunications RAFs. I have attached Order No. PSC-2021-0159-PAA-TX that details the steps the company must take in order to avoid cancellation of its certificate. Specifically, the company must remit payment of all past due RAFs (including P&I) and must also

remit payment of the \$500 non-compliance fee. These payments totaling \$1,111.80 must be received prior to the issuance of the Consummating Order in this Docket, as detailed in the attached PAA Order.

As I mentioned during our phone call, I encourage you to mail this payment in a method that can be tracked, such as FedEx or UPS. We have had many issues with mail delivery this year, which makes a tracking number or method very helpful.
