4	service in Charlotte County by EULLC. Ms. Mary

23	the Commission to rule on this matter,

2	whether it wants to hear oral argument and from
3	whom. Ms. Cotherman, a representative for the
4	utility, and a few potential customers are on the
5	telephone. Staff is available to answer your
6	questions.
7	CHAIRMAN CLARK: Thank you, Ms. Helton. As a
8	reminder to the Commissioners, there were no points
9	of law that were found to be any different than
10	what was considered originally. So I is there
11	any Commissioner that wants to hear oral arguments
12	on the reconsideration?
