2	CHAIRMAN CLARK: Next up Item No. 1, Ms.
3	Weisenfeld.
4	MS. WEISENFELD: Good morning, Commissioners.
5	Ashley Weisenfeld with Commission Staff.
6	Item No. 1 is staff's recommendation on the
7	petition for designation as an eligible
8	telecommunications carrier, or ETC, filed by AB
9	Indiana, LLC.
10	Staff recommends that the Commission does not
11	have jurisdiction to grant AB Indiana, LLC, ETC
12	status in Florida, and that the company should
13	apply directly to the FCC for ETC designation.
14	Staff is available for any questions.
15	CHAIRMAN CLARK: Thank you, Ms. Weisenfeld.
16	Commissioners, do you have any of questions?
17	Commissioner Fay.
18	COMMISSIONER FAY: Thank you, Mr. Chairman.
19	I appreciate the data that was provided
20	regarding the various companies that have come
21	before on this. I know that this is a large chunk
22	of money for rural broadband, and I think that our
23	role has been one consistently of denying these
24	that come before us, to allow the FCC to have
25	jurisdiction, but just so I understand, the item

1	that's in front of us, is this the last this is
2	the last utility that will come before us regarding
3	these funds?
4	MS. WEISENFELD: Thank you for the question,
5	Commissioner. And, yes, that is my understanding.
6	COMMISSIONER FAY: Okay. Great.
7	And then can you just confirm it looked
8	like, looking at the data, Mediacom was the only
9	entity that didn't have some some alternative
10	jurisdiction approval already that didn't come
11	before us, but is going before the FCC?
12	MS. WEISENFELD: Yes. It is my understanding
13	that Mediacom applied directly with the FCC for ETC
14	designation.
15	COMMISSIONER FAY: Okay. Great. So we don't
16	anticipate any issues, since the deadline is
17	closing, for that entity that hasn't come before
18	us?
19	MS. WEISENFELD: I don't, but I will defer to
20	technical staff just to confirm that.
21	COMMISSIONER FAY: Great.
22	MS. DE AYALA: Good morning, Commissioners.
23	Yes, Mediacom has got their ETC designation from
24	the FCC.
25	COMMISSIONER FAY: Okay.

1	MS. DE AYALA: So we don't have any other
2	coming.
3	COMMISSIONER FAY: Great. Thank you. Yeah, I
4	just want to make sure. We sometimes when you
5	read these recommendations, and we are we are
6	denying their request, it appears that we are we
7	are getting in the way of this, but I think it's
8	quite the opposite. They need to go to the FCC for
9	their approval.
10	That answers all my questions. So with that,
11	Mr. Chairman, I move for approval of staff
12	recommendation on Item 1.
13	CHAIRMAN CLARK: I have a motion.
14	Do I have second? Do I have a second?
15	We have a motion and a second to approve staff
16	recommendation on Item No. 1.
17	Any discussion from the Commission?
18	All in favor say aye.
19	(Chorus of ayes.)
20	CHAIRMAN CLARK: All opposed?
21	(No response.)
22	CHAIRMAN CLARK: The motion carries.
23	All right. That includes concludes our
24	Agenda items for the day.
25	Again, let me say thank you to everyone who

1	came out today. It's great to see a live studio
2	audience again. It's kind of a new treat for us, a
3	lot of a lot of faces we haven't seen in a long
4	time, but it's great to have you all back with us,
5	and look forward our live hearings from this point
6	on.
