NOTICE IS HEREBY GIVEN that on August 3, 2021, the Florida Public Service Commission received a petition for temporary variance or waiver from Florida Power & Light Company, in Docket No. 20210128-EI, seeking a temporary variance from or waiver of Rule 25-6.0143(1)(g), Florida Administrative Code. The rule addresses accounting for storm-related damages and requires an investor-owned electric utility to file by September 30 a petition for the disposition of any costs deferred prior to June 1 of the year following the storm event giving rise to the deferred costs.
