Dear Public Service Commission,

As a resident of Florida, I urge you to decline FPL's rate increase petition, which would create an unnecessary and excessive burden on utility customers at a time when many Floridians can least afford to pay more for their unavoidable daily expenses.

FPL is trying to charge customers like us for a range of projects we do not want or need. FPL does not need to spend billions of our dollars to build redundant fossil fuel units, rebuild an already-sufficient transmission system, and give their shareholders a raise.

FPL is promising to heavily invest in producing solar power for Florida's ratepayers. To do so, they will build solar fields totaling thousands of solar panels. Those panels, while long-lived, will eventually decay and need to be replaced. FPL must be obligated to use only the best available recycling technology to accomplish safe discard of solar panels since they contain many dangerous components. This technology will change over time and FPL must adopt whatever is the then current best technology, additionally, since FPL will be the major generator of dfailed solar panels, they MUST be required to accept from ordinary consumers, their solar panels for recycling at no cost. That will avoid a new stream of hazardous municipal waste.

Please do not put FPL's desire to maximize profits over our need to power our homes affordably.
