

FAR NOTICE OF HEARING

PUBLIC SERVICE COMMISSION

The FLORIDA PUBLIC SERVICE COMMISSION announces a continuation of the final hearing in the following docket to which all persons are invited.

DOCKET NO. AND TITLE: Docket No. 20210015-EI - Petition for rate increase by Florida Power & Light Company.

HEARING DATE AND TIME: Monday, September 20, 2021, at 9:30 a.m. September 21 and 22, 2021, have also been reserved for continuation of the hearing if necessary. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

PLACE: Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purpose of this hearing shall be to receive testimony and exhibits and to take final action relative to Florida Power & Light Company's request for a rate increase and consolidation of its rates with those of Gulf Power Company, to take supplemental testimony on the Stipulation and Settlement Agreement dated August 9, 2021, and to take action on any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. This proceeding shall: (1) allow the parties to present evidence and testimony in support of their positions; (2) allow for such other purposes as the Commission may deem appropriate.
