On September 17, 2021, International Telcom, LLC filed a notice of a transfer of control of Magna5 LLC to International Telcom, LLC. The filing also included an application to provide telecommunication service in Florida with the \$500.00 application fee. Subsequently, Docket No. 20210156-TX was established. Upon review, staff discovered this transaction does not require Commission approval. As a result, staff instructed International Telcom, LLC to withdraw its filing and resubmit appropriately. On September 21, 2021, International Telcom, LLC sent the attached memo withdrawing its filing.

On October 1, 2021 a memo was filed requesting closure of Docket 20210156-TX and return of check submitted by Company. The attachment was omitted and therefore attached is a revised memo with the attachment. If you have additional questions please let me know.

This docket was erroneously opened by International Telcom, LLC. Therefore, pursuant to Section 2.07 C.2.d(1), of the Administrative Procedures Manual, staff requests that Docket No. 20210156-TX be administratively closed and International Telcom, LLC application fee of \$500.00 (check #8835149) be refunded.
