PURPOSE AND PROCEDURE:

The purpose of the technical hearing is to consider the petition of Environmental Utilities, LLC for application for an original wastewater certificate in Charlotte County, and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on January 26, 2022. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

Any member of the public who wants to observe or listen to the proceedings may do so by accessing the live video broadcast the day of the hearing, which is available from the Commission website at at www.FloridaPSC.com. SERVICE HEARINGS

The purpose of the customer service hearings is to give prospective customers of the Utility and other interested persons an opportunity to offer testify regarding the application of the Utility for a wastewater certificate in Charlotte County.
