Dear Mr. Teitzman:

We represent Wire 3 LLC ("**Wire 3**") with respect to its certificate of authority issued on October 13, 2021 ("**Certificate**") by the Florida Public Service Commission ("**FPSC**"). As discussed in the enclosed, Wire 3 recently underwent a financing transaction that resulted in the change of control of its parent company. Accordingly, on behalf of Wire 3, and in accordance with Fla. Stat. § 364.33, we write to provide the FPSC with notice of such transaction.

Pursuant to Fl. Stat. Ann. § 364.183(1), proprietary confidential business information filed with the Commission shall, upon request, be kept confidential and exempt from public disclosure. As used in this context, proprietary confidential business information means information, regardless of form or characteristic, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the person's company or business operations and has not been otherwise disclosed. Fl. Stat. Ann. § 364.183(3). The information enclosed herewith is proprietary confidential information as that term is defined under Florida law because it is owned by Wire 3, is treated by Wire 3 as private since its disclosure would harm Wire 3's company and business operations, and has not otherwise been disclosed. *See id.* at § 364.183(3). Therefore, we respectfully submit that this information is entitled to confidential treatment and is exempt from public disclosure. *See id.* at § 364.183(1).
