1 PROCEEDINGS 2 CHAIRMAN FAY: And with that, we'll move on to 3 items for discussion, Item 3. 4 MR. LEWIS: Good morning, Commissioners. I'm 5 Clayton Lewis representing staff. Item No. 3 is staff's recommendation regarding 6 7 Gibson Place Utility Company, LLC's, request to 8 leave a portion of its territory. Gibson Place is 9 a water and water -- excuse me -- water and 10 wastewater utility in Lake and Sumter Counties that 11 has not begun serving customers, and initial rates 12 will be set at a later date. 13 Staff recommends the Commission approve the 14 utility's request to delete the territory. 15 Staff is available to answer your questions. 16 CHAIRMAN FAY: Great. Thank you for that 17 summary, Mr. Lewis. 18 I have a question for this. I pulled this --19 So, I asked you if -- I asked you about this item. 20 some of this in briefing, but essentially, from 21 what I understand on this, this is a bit unusual to 22 have a portion of a territory deleted and removed from the -- this, but there's no risk of customers 23 24 in this area not having service because there's 25 nothing built?

1 MR. LEWIS: Yeah, there's --2 CHATRMAN FAY: Is that -- is that correct? 3 MR. LEWIS: Yes, sir, there's -- no facilities have been built; that is, the water and wastewater 4 5 facilities, treatment plants have not been sited yet or approved by DEP, but there's no customers at 6 7 all that will be affected. 8 CHAIRMAN FAY: Okay. And will there be any 9 obligation for the municipality to provide the 10 service or would it just be when -- if -- if 11 something is built, then there would be an entity 12 at that time that we would certify? 13 MR. LEWIS: As far as the remaining territory? 14 Yes. CHAIRMAN FAY: 15 Yes. Yeah. Okav. 16 I think that's all I have for that one. Ι 17 just, of course, want to make sure that we're not removing something from a territory that would 18 19 potentially need service. 20 But have we had this happen before, I quess? 21 Yes, sir. Not too recently, I MR. LEWIS: 22 believe it was South Sumter -- I was not on that 23 particular case -- but they deleted territory in 24 the same, similar fashion earlier, I believe, this 25 year.

1 CHAIRMAN FAY: Okay. Great. I've got a comment. 8 COMMISSIONER GRAHAM: You 9 stressed out poor Mr. Wharton over there, just 10 wanting to say something. 11 MR. WHARTON: I -- I -- I'm here, substituting 12 for Marty Friedman on this matter. Ten minutes 13 ago, I called him and said (unintelligible). 14 (Laughter.) 15 Mr. Wharton, you -- you --CHAIRMAN FAY: 16 MR. WHARTON: I do know quite a bit about this 17 client, its ability -- they're very meticulous in 18 the way they do things. They work a lot with local 19 government. 20 I don't think there's anything to be concerned 21 about in terms of how -- I don't know their 22 specific reasons, but they are very put-away in 23 terms of how they, their neighbor properties, are 24 treated and how they and local government interact 25 in providing utility services.
