Dear Clerk and Commissioners,

My husband, George Shopp and I own the property at 9866 Little Gasparilla Island. We are writing to request that you deny Environmental Utilities' application for Original Certificate of Authorization for the proposed sewer system (Docket 20200226).

After reading expert testimony, it is not clear to me that degree of pollution from septic systems warrants installation of a sewer system.

I wonder if the potential environmental benefits of the proposed sewer system would be worth the disruption to the island. Numerous turtles, birds and other animals nest where the power lines run through our property (which I assume is where EU proposes accessing our property). We looked into burying power lines 5 years ago and one thing FPL told us that the turtle nest would need to be relocated at a cost of \$3000 per nest.

Is it known whether certain septic systems are causing problems and others aren't? Perhaps it would make more sense to assess the status of septic systems on the Island to ensure they are compliant. If it turns out we do need a sewer system, I would not entrust the planning and installation of a sewer system to a private company. What is the reasoning behind using a private company with no experience? Can the county take on this responsibility?

I have not seen any plan for the type of system or its installation. This will be a unique job and require expertise. It is my understanding that EU has no experience with sewer systems.

Dear Commissioner Clark:

I am writing to formally request that you deny EU's application for wastewater service to Palm Island in Charlotte County. I am a property owner within the proposed service area of Palm Island at 421 Kettle Harbor Drive, Placida. This is a small barrier island with mostly second homes that are unoccupied by owners or renters a large portion of the time. It is a rural area where owners make environmental conservation and wildlife preservation a high priority. As a rural area, Charlotte County has discouraged central sewer system infrastructure that would promote higher density residential or commercial development. We have a large gopher tortoise population and a thriving sea turtle nesting season that would be jeopardized by overdevelopment and potentially by large scale machinery brought in to run sewer pipes, install holding tanks, and crush existing septic systems. To my knowledge, there have been no studies of the water quality in this service area that prove contamination from the current septic systems. The county ordinance requires inspection and pumping of septic system at regular intervals and there have been no documented septic system failures. There is no guarantee that conversion to a sewer system will eliminate nitrate and phosphate contamination, as evidenced by the contamination documented in Rotunda. There is also the risk of a sewage leak into surrounding waterways which would be more catastrophic than an isolated septic system failure.

Until the need for conversion from septic to sewer on Palm Island is supported by water quality testing, I do not see the rush to grant EU permission to develop a private sewer system. I have not seen any concrete data showing the feasibility and cost of such a project. I do not believe EU has the technical expertise to undertake a sewer project. I strongly believe that if such a project is deemed necessary for environmental reasons, that it should be constructed and managed by Charlotte County, not a private company that has not determined costs of hook-up and maintenance and that will not be regulated to ensure that we Charlotte County residents will be charged fair and equitable rates as compared with other residents of the county. In addition, it is my understanding that the pump requires electricity, which is frequently disrupted on this island for long periods of time. This could cause sewage back-up. Disruption of the existing septic tanks on the island may require destruction of mature landscaping which in turn will affect wildlife on the island. I am also against the easement EU has requested that would go from the sewer equipment close to my home to the road. I have strong concerns regarding EU's ability to provide emergency service for sewer system issues, particularly on a barrier island only accessible by ferry from 6:30 am to 10 pm. Please, before rushing into such a large project with a private company without experience in sewer system construction, deny EU's application for wastewater service until you are presented with more data showing the need for such service and the cost for the installation and maintenance of such service.

Thank you very much for your consideration of my concerns.

I'm writing to you in regard to Docket #20200226-SU. My name is Ember Harker, ember@launchsnap.com. I'm currently building a new home at 381 Kettle Harbor Drive on Palm Island. This will be our primary residence where we plan to stay as long as we are able.

My family has been coming to this island for decades. The unique charm of this island simply cannot be imagined. From the car ferry that takes you onto the island, to the sand roads and golf carts, to the hawks, dolphins, manatees and gopher tortoises, to houses floating on stilts in the air, and the pristine white sand and blue water beaches...palm island is without question, magical.

We feel a profound sense of gratitude to be able to build our forever home on this island. We've dreamed of it for years but it's been financially out of our grasp. In order to build this home, we sold our home and have been living with my inlaws until our house is built. Imagine moving in with your mom at 50 years old...that's how committed we are to making this dream come true.

Our home isn't huge by most standards but it's every penny we can afford and part of that is a brand new, state of the art septic system. Which brings me to the proposed sewer service. I oppose this proposal for several reasons:

1. There's no consideration for the age of the septic system. Instead everyone would be forced to transition to the sewer regardless of the age of the system or need to be replaced. It makes no sense to rip out a brand new system.
2. We simply cannot afford it. We've put everything into this house and having to come up with such a huge chunk of money for a service *we don't want and did not request* after having just put in a brand new septic would be an incredible burden.
3. There is a complete lack of transparency around the financial implications of the proposed sewer. I don't feel that adequate due diligence has been performed and do not feel any sense of confidence about the cost of this endeavor short term or long term.
4. There's no proven need for sewer. We are strong advocates for greener living and plan to have a chemical free property. We've read the research and do not see any credible need for sewer nor proof that the septic systems on the island are causing harm.
5. I do not feel that the applicant has the technical experience appropriate to take on such a project. I'm not sure why someone who has never done a project like this would even apply or ever be granted a permit.
