NOTICE is hereby given that the staff of the Florida Public Service Commission (Commission) is seeking comment and information from utility customers pertaining to the petition of HC Waterworks, Inc. (HCWW or Utility) for a limited proceeding in Highlands County.

PURPOSE

These comments will be taken into consideration by the Commission in its decision regarding the proposed rate increase.

BACKGROUND

HC Waterworks, Inc. (HCWW or Utility) is a Class B utility providing water service to approximately 967 residential customers, 12 general service customers, and 1 private fire protection customer in the Leisure Lakes, Lake Josephine, and Sebring Lakes subdivisions in Highlands County. The Utility also provides wastewater service to 317 residential wastewater customers in the Leisure Lakes subdivision. The service area is in the Southwest Florida Water Management District and is in a water use caution area. According to the Utility's 2020 Annual Report, operating revenues were \$712,733 for water and \$90,118 for wastewater. Operating expenses were \$513,226 for water and \$95,155 for wastewater.

By Order No. PSC-2014-0314-PAA-WS, the Commission approved the transfer of Certificate Nos. 422-W and 359-S from Aqua Utilities Florida, Inc. to HCWW.¹ Water rates were last established for the Utility in 2020.² Subsequently, water rates were increased by a price index rate adjustment in 2021. Wastewater rates were last established in 2015 and had subsequent price index rate adjustments in 2018 and 2021.³ On November 18, 2021, HCWW filed its application for a limited proceeding to increase its water and wastewater rates.⁴ Accompanying the Utility's application were minimum filing requirement (MFR) schedules required by Section 367.081, Florida Statutes (F.S.), and Rule 25-30.437, Florida Administrative Code (F.A.C.). The Utility was notified of deficiencies in the MFRs on December 14, 2021.⁵ The deficiencies were cured and December 22, 2021, was established as the official filing date.⁶

The Utility is requesting an increase to address significant financial impacts to HCWW's earning levels beginning in April 2021. Based on the Utility's filing, their expenses will not be recovered through current rates.

CURRENT AND PROPOSED MONTHLY WASTEWATER RATES

PROCEDURES AFTER RECEIVING COMMENTS

Commission staff will prepare a recommendation on the Utility's proposed rate increase which is tentatively scheduled to be submitted to the Commission on April 21, 2022. The Commission will then vote on staff's recommendation, taking into consideration customer comments, at its May 3, 2022 Commission Conference. As noted above, customers may address the Commission directly at this Conference. Customers may also watch the Commission Conference live from the PSC website at <u>www.floridapsc.com</u>. Look for the "Watch Live Broadcast" icon on the left side of the webpage.

The Commission will thereafter issue a proposed agency action (PAA) order containing rates which may be different from those contained in staff's final recommendation. Substantially affected persons have 21 days from the date that the PAA order is issued to protest the Commission's PAA order. Customers may obtain a copy of staff's recommendation and all documents filed in this docket under the Clerk's Office tab at the Commission's website (http://www.floridapsc.com).
