2 CHAIRMAN FAY: Next, we will move on to Agenda
3 Item No. 4. Ms. Cibula will introduce the item.

4 MS. CIBULA: Samantha Cibula, the Commission's
5 legal staff.

6 Item 4 is a petition by Florida Power & Light
7 Company for a temporary waiver of subsection (3) of
8 Rule 25-6.078 of the Florida Administrative Code.

9 This rule addresses contributions in aid of
10 construction for the installation of electric
11 underground facilities in new residential
12 subdivisions and requires investor-owned electric
13 utilities to file the utility's written policy and
14 supporting data at least every three years.

15 This information would be due for FPL on April
16 1st of this year. FPL is seeking a temporary
17 waiver of the rule to provide this information by
18 April 2023, which would align this filing with that
19 of Gulf Power Company, and would allow FPL to file
20 the data on a combined, more meaningful basis.

21 Staff believes that FPL has met the
22 requirements under Subsection 120.542 of the
23 Florida Statutes for a temporary rule waiver, and
24 recommends that the Commission grant FPL's request.

25 Staff is available for questions.

1 CHAIRMAN FAY: Great. Thank you, Ms. Cibula.

2 With that, Commissioners, I will take a motion

3 on that item.

4 COMMISSIONER CLARK: Move staff

5 recommendation, Mr. Chairman.

6 CHAIRMAN FAY: We have a motion and a second.
