1 PROCEEDINGS 2 CHAIRMAN FAY: Next we will go to Item No. 10, 3 presented by Mr. Hampson. 4 Mr. Hampson, you are recognized. 5 Morning Commissioners. MR. HAMPSON: This is Corey Hampson with the Division of Economics. 6 7 Item 10 is Florida Public Utility Company's 8 petition for the authority to permanently reinstate 9 its non-firm energy program and tariff which was 10 formerly approved as a pilot. The tariff allows 11 qualifying industrial customers to purchase 12 non-firm energy from the utility at the wholesale 13 rate offered by FPL. 14 FPUC demonstrated that during the pilot, that 15 the tariff benefited participants through lower 16 energy costs, and in addition, FPUC's general body 17 of ratepayers should benefit through lower fuel 18 factors when future agreements or wholesale power 19 are negotiated. 20 Staff recommends that the Commission should 21 approve the proposed tariff as the utility has 22 demonstrated the tariff's benefits to the general 23 body of ratepayers and the program participants. 24 CHAIRMAN FAY: Great. Thank you, Mr. Hampson. 25 With that, Commissioners, you have heard the
