3 Commissioner La Rosa. So this morning we will take
4 up items 3, 4, 8 and 9 first, with the move staff,

6 and 7 for further discussion.

7 So, with that, I would start with you, Mr.
8 Higgins, for a presentation summary of Item 3.

9 MR. HIGGINS: Good morning, Commissioners.
10 Devlin Higgins with Commission staff. Item No. 3
11 is staff's recommendation concerning Tampa Electric
12 Company's petition for a mid-course correction of
13 it's currently approved fuel and capacity charges.
14 The primary reason for the company's mid-course
15 correction filing is natural gas costs being
16 greater than originally estimated. Staff's
17 recommendation is for the company's fueling
18 capacity cost recovery factors to be adjusted to
19 encompass the two subject under-recoveries
20 beginning with the April 22 billing cycle. Staff
21 is not aware of any comments from the general
22 public with respect to this matter, nor any
23 interested parties wishing to address the
24 Commission.

2 summary. Commissioners, you've heard the summary
3 and the recommendation of the item. I will


