Item 9 is a joint 5 petition by Tampa Electric Company and 6 7 Withlacoochee River Electric Cooperative requesting 8 approval of an amendment to their currently 9 effective territorial agreement. Specifically, the 10 joint petitioners seeks to adjust their service 11 boundary within new development known as Two Rivers 12 Under the proposed amendment, TECO could Ranch. 13 gain 475 new residential customers in the transfer 14 of proposed lots in Withlacoochee's current 15 territory, and Withlacoochee could gain 561 new 16 residential customers from the transfer of proposal 17 lots in TECO's current territory. All other 18 aspects of the currently effective territorial 19 agreement would remain unchanged. Staff is not 20 aware of any customer complaints or correspondence 21 regarding this docket and recommends approval of 22 this joint petition by TECO and Withlacoochee. 23 CHAIRMAN FAY: Thank you for the summary, Mr. 24 Ward.
