In response to your Test Year Notification Letter dated March 24, 2022, the Florida Public Service Commission (Commission) has opened Docket No. 20220067-GU for Florida Public Utilities Company, Florida Division of Chesapeake Utilities Corporation, Florida Public Utilities Company - Fort Meade, and Florida Public Utilities Company - Indiantown (Companies) forthcoming general base rate increase proceeding. It has been noted that the Companies propose to utilize a projected 12-month test year period ending December 31, 2023, for the permanent rate increase proceeding. The Companies' test year request is hereby approved for purposes of filing its Minimum Filing Requirements. Please be advised that approval of the test year for filing purposes does not mean that the appropriateness of the selected test year could not be raised as an issue in the proceeding.

It is my understanding that the Companies intend to make their filing no earlier than May 24, 2022, in order to be in compliance with Rule 25-7.140(1), Florida Administrative Code (F.A.C.). If the Companies are unable to file on May 24, 2022, they must notify the Commission in accordance with Rule 25-7.140(3), F.A.C.
