2 CHAIRMAN FAY: Commissioners, we'll move on to  
3 Item No. 7 to be presented by Ms. Forrest. Ms.  
4 Forrest, you're recognized.

5 MS. FORREST: Good morning, Commissioners.  
6 Item No. 7 is a petition by Florida Public  
7 Utilities Company to modify its existing lighting  
8 tariff rate schedule LS, to allow for  
9 light-emitting-diode lighting options. The  
10 petition also requests approval to close the older  
11 technology lighting options and rates to new  
12 customers. Current customers with those older  
13 technology lighting options would remain under  
14 those rates until a light needs to be replaced. At  
15 that time, a light would be replaced with an LED  
16 fixture and billed under the new LED rates. The  
17 utility proposes to add 15 new LED fixture options  
18 as a modification, the rate schedule LS. Those  
19 options can be found on tariff sheet 57. Thank  
20 you.

21 CHAIRMAN FAY: Great. Thank you, Ms. Forrest,  
22 for the presentation. With that, Commissioners,  
23 you have a description of Item 7. I will entertain  
24 a motion.

25 COMMISSIONER CLARK: Move to approve the

1 tariff, Mr. Chairman.

2 COMMISSIONER GRAHAM: Second.

3 CHAIRMAN FAY: I have a motion and a second.
