We continue to greatly appreciate your attention to the matter of Docket #20200226-SU.

We ask that you follow the **staff recommendation to deny the application.**

This system will make NO difference for the environment except for harming it all the while only helping one family financially. Please do not allow our pristine island to be torn apart and abused.

Just a week ago there was a water main issue on the mainland and ALL of LGI was without water for about an hour or so. Then we were on a boil water notice for 2 days. HOWEVER, there was NOT one mass email or phone call/text sent from LG Water Utility to paying customers let anyone know about the issues. They instead replied upon word of mouth, Facebook posts in LGI groups (unaffiliated with them), texts from people who have their number and apparently they put it on their website (which no one would know to go to). This company HAS all of our emails to send us bills but do not have a system set up to let us know when there is a health hazard. People on the island were drinking the water all weekend having no idea they were supposed to boil it.

This is the company that wants to be in charge of sewage.

Please, we implore you, deny the application.
