**SECTION 63.71 APPLICATION
OF NEC CLOUD COMMUNICATIONS AMERICA, INC.**

NEC Cloud Communications America, Inc. ("Applicant") seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue its Original BLUE UCaaS and Original BLUE Contact Center and accompanying products in all states and jurisdictions where the service is offered. Applicant will also cease to provide Original BLUE UCaaS and Original BLUE Contact Center products and services, along with technical support, to customers currently under contract on July 15, 2022. Applicant will suggest alternative services to customers, and waive all cancellation fees associated with termination of services. Applicant will further refund all customers pro-rated fees associated with any pre-payments received for the balance of the customer's term.

Subject to Commission authorization, on July 15, 2022, Applicant plans to discontinue these products and services completely after July 15, 2022. Customers will be able to obtain alternative services and products from NEC Cloud Communications America, Inc. or other providers that perform the same functions as these services.

Applicant submits the following information pursuant to Section 63.71 of the Commission's rules:

1. Name and Address of the Carrier

NEC Cloud Communications America Inc. located at 3929 W. John Carpenter Freeway, Irving TX.

2. Date of Planned Service Discontinuance

As of July 15, 2022, or as soon thereafter as the necessary regulatory approvals can be obtained, Applicant will no longer offer its Original BLUE UCaaS and Original BLUE Contact Center products and services to new customers or accept new orders from existing customers (except to the extent such orders are permitted by contract). Applicant is working with customers with contracts for the affected services to transition them to alternative services after their contracts expire.

3. Points of Geographic Areas of Service Affected

AL, AR, AZ, CA, CO, FL, GA, IN, KY, LA, MA, MD, MI, MO, NC, NJ, NY, OH, OK, PA, TX.

4. Description of Services Affected

Original BLUE UCaaS and Original BLUE Contact Center business communication services, which include interconnected VoIP service.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers

Customers that are currently subscribed to the affected services were provided notice on or before June 15, 2022. Copies of the notifications are attached to this application as Attachment A.

Also, on June 8, 2022, Applicant sent copies of this Application via electronic mail or First Class Mail to the public utility commission and to the Governor of each affected state, federally- recognized tribal nations in each state, and the Secretary of Defense, Attention Special Assistant for Telecommunications, as required by Section 63.71(a) of the Commission's rules.

6. Whether the Carrier is Considered Dominant or Non-dominant with Respect to the Service to be Discontinued

Applicant is considered non-dominant with respect to the services to be discontinued.

CONCLUSION

The public convenience and necessity will not be adversely affected by the discontinuance of the services described herein. Advanced notice has been provided to all affected customers who will continue to receive services under the existing contracts through the contract term. Customers have also been given ample time to arrange substitute services, which are already available in the marketplace, upon expiration of their existing contracts. Therefore, Applicant respectfully requests that the Commission approve this Section 63.71 application.
