6	CHAIRMAN FAY: All right. Thank you,
7	Commissioner La Rosa.
8	With that, I would like to call the June 7th
9	Agenda Conference to order. Commissioners, we will

23	upon adoption of procedural Rule 25-18.010 pole
24	attachment complaints.
25	Staff recommends that the Commission should

1	file its certification with the FCC as shown in the
2	staff recommendation after the rule becomes
3	effective.
4	Also, the Commission's information, last
5	Friday afternoon we were advised by FCC legal staff
6	that orders are on circulation and are pending
7	action by the full FCC that, if issued, would
8	resolve AT&T's pending pole attachment complaints
9	against FPL.
10	Staff is available to answer any questions.
11	CHAIRMAN FAY: Great. Thank you, Ms. Cowdery,
12	for that summary.
13	Is this your last meeting?
14	MS. COWDERY: Yes.
15	CHAIRMAN FAY: Awe. So sad. Well, maybe we
