7	Item 3 is staff's recommendation regarding the
8	annual reestablishment of the authorized range of
9	returns on equity for water and wastewater
10	utilities pursuant to Section 367.081 of the
11	Florida Statutes.
12	Staff recommends that the leverage formula be
13	updated to reflect current market conditions, and
14	be used until the leverage formula is readdressed
15	next year.
16	The results of this year's leverage formula
17	returned a range of 7.84 percent at a 100-percent
18	equity ratio to 10.45 percent at a 40-percent
19	equity ratio.
20	CHAIRMAN FAY: Great. Thank you, Mr. Osorio.
21	Commissioners, with that, you have heard the
22	item. I will entertain a motion.
