The FLORIDA PUBLIC SERVICE COMMISSION announces a prehearing conference and a hearing in the following dockets to which all persons are invited.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE PREHEARING:

The purpose of this prehearing conference is to: (1) simplify the issues; (2) identify the positions of the parties on the issues; (3) consider the possibility of obtaining admissions of fact and of documents which will avoid unnecessary proof; (4) identify exhibits; (5) establish an order of witnesses; and (6) consider such other matters as may aid in the disposition of the action.

HEARING DATE AND TIME: Tuesday, August 2, 2022, immediately following the 9:30 a.m. Commission Agenda Meeting. August 3, 2022, and August 4, 2022, have also been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purpose of this hearing shall be to receive testimony and exhibits and to take final action relative to the Commission's Review and Determination as to whether it is in the public interest to approve, approve with modification, or deny the transmission and distribution storm protection plans submitted pursuant to Section 366.96, Florida Statutes (F.S.), and Rule 25-6.030, Florida Administrative Code (F.A.C.), by Tampa Electric Company, Duke Energy Florida, LLC, Gulf Power Company, and Florida Power & Light Company. The Commission may also take action on any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. This proceeding shall: (1) allow the parties to present evidence and testimony in support of their positions; (2) allow for such other purposes as the Commission may deem appropriate.

All witnesses shall be subject to cross-examination at the conclusion of their testimony. This proceeding will be governed by Chapters 366 and 120, F.S., and Rules 25-22, and 28-106, F.A.C.
