**Re: Docket No. 20220049-EI: Review of Storm Protection Plan pursuant to Rule 25-6.030,
F.A.C., Florida Public Utilities Company**

Dear Mr. Teitzman:

At Staff's request, FPUC offers this letter to clarify the documents for which confidentiality has been requested as it pertains to the Testimony of OPC Witness Mara.

FPUC seeks confidential classification of the highlighted lines on pages 24 and 25 of the Testimony of Kevin Mara, which was submitted by the Office of Public Counsel ("OPC"). This information was originally filed by OPC on May 31, 2022. [See Document No. 3314-2022]. In accordance with Rule 25-22.006, F.A.C., FPUC timely submitted a Notice of Intent to Seek Confidential Classification the same day without including an additional copy of the referenced confidential document. Because the Rule requires that the confidential material be submitted with the Notice of Intent, FPUC provided the confidential material again on June 7, 2022. [See Document No. 3473-2022]. Subsequently, in accordance with the Rule, FPUC submitted a Request for Confidential Classification - again with the confidential material attached. [See Document No. 04181-2022] FPUC was later notified by PSC Staff that the confidential material included with the Request was missing one of the confidential pages. Therefore, at Staff's request, FPUC resubmitted the confidential material on June 30, 2022. [See Document No. 04400-2022]. The submission on June 30, 2022, was intended as a replacement for the submission on June 21, 2022. [Document No. 04181-2022].

In sum, FPUC is asking for confidential classification of the highlighted information on pages 24 and 25 of Mr. Mara's testimony. To the extent that [Document No. 04181-2022] has been replaced, FPUC respectfully asks that it be returned to the Company. The Company also respectfully suggests that, given that Document No. 3314-2022 and 3473-2022 are also redundant, one of those versions could also be returned to the Company. This would leave only two copies on file with Commission, Document No. 04400-2022, and the version of the noted redundant

versions [Document No. 3314-2022 or 3473-2022] that is retained by the Commission. This would be consistent with the Rule which requires one copy be submitted with the Notice of Intent, and one be submitted with the Request for Confidentiality.
