4 MS. GUFFEY: Item 9 is Florida Public  
5 Utilities Company Florida Division of Chesapeake  
6 Utilities Corporation, Florida Public Utilities  
7 Company Fort Meade and Florida Public Utilities  
8 Company Indiantown Division, collectively FPUC,  
9 petition seeking Commission approval of a rate  
10 increase.

11 FPUC requested that this rate case should be  
12 handled using the Commission's hearing process.  
13 Accordingly, an administrative hearing has been  
14 scheduled for this docket from October 25th through  
15 the 28th, 2022. It is staff's recommendation to  
16 suspend the proposed final rates and charges to  
17 allow staff and the parties sufficient time to  
18 review the case, and for the Commission to conduct  
19 a hearing.

20 CHAIRMAN FAY: Great. Thank you, Ms. Guffey.  
21 Commissioners, on this panel Item No. 9 I will  
22 entertain a motion.

23 COMMISSIONER PASSIDOMO: Mr. Chairman, move  
24 approval of staff's recommendation.
