11 new agreement.

12 The new agreement reflects changes to the
13 acquired boundaries to accommodate new subdivisions
14 that have been developed since 2006. The new
15 agreement will allow the two utilities to serve
16 electric service to their current and future
17 customers in an economical and efficient manner.

19 Lakeland and Bartow.
