On May 31, 2022, Florida City Gas (FCG) filed a request for confidential classification pursuant to Section 366.093(3)(e) of the Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C), for information contained in the Company's MFRs filing for the above referenced docket.

FCG claims the confidential information is intended to be and has been treated by FCG as private, its confidentiality has been maintained, and its disclosure would cause harm to FCG and its customers. Pursuant to Section 366.093, F.S., such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the public records law. FCG also claims that the confidential information contains information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. Specifically, the material contains tax returns and schedules, including pro forma tax documentation incorporated into NextEra Energy Inc.'s tax return, which is confidential pursuant to 26 U.S.C. § 6103. This information is protected by Sections 366.093(3)(e), F.S.

In staff's opinion, the request meets the criteria for confidentiality set forth in Section 366.093(3)(e), F.S. and 26 U.S.C. § 6103. Therefore, staff recommends that FCG's request for confidential classification of the information contained in Document No. 03259-2022 be approved.
