
T-Mobile South LLC (“T-Mobile”), pursuant to Section 364.183(1), Florida Statutes, hereby claims that the information provided in the attached FCC Form 497 Reports contains confidential customer information that should be held exempt from public disclosure. Pursuant to Rule 25-22.006(5), Florida Administrative Code, the attached sealed envelope contains the documents with the confidential information. T-Mobile, as a commercial mobile radio service or wireless carrier, is exempt from this Commission’s jurisdiction pursuant to sections 364.011(4) and 364.02(13)(c), Florida Statutes, and not required to respond to the PSC’s annual data requests. However, T-Mobile is providing its Florida Lifeline customer count information as filed with the FCC on FCC Form 497 on a confidential basis as a courtesy to the Commission for the limited purpose of this year’s annual Lifeline report to the Florida Legislature.
