## TAMPA ELECTRIC COMPANY'S PRELIMINARY LIST OF ISSUES AND POSITIONS

Tampa Electric Company ("Tampa Electric" or "the company"), hereby submits its Preliminary List of the Issues and Positions to be taken up at the hearing scheduled to commence on November 1, 2022 in the above docket.

## **GENERIC CONSERVATION COST RECOVERY ISSUES**

**<u>ISSUE 1</u>**: What are the final conservation cost recovery adjustment true-up amounts for the period January 2021 through December 2021?

<u>**Tampa Electric's Position</u>**: An over-recovery of \$10,818,286, including interest. (Witness: Roche)</u>

**ISSUE 2**: What are the appropriate total conservation adjustment actual/estimated true-up amounts for the period January 2022 through December 2022?

<u>**Tampa Electric's Position</u>**: An under-recovery of \$10,456,363, including interest. (Witness: Roche)</u>

**ISSUE 3**: What are the appropriate total conservation adjustment true-up amounts to be collected/refunded from the period January 2023 through December 2023?

Tampa Electric's Position: A refund of \$361,923, including interest. (Witness: Roche)

**<u>ISSUE 4</u>**: What are the total conservation cost recovery amounts to be collected during the period January 2023 through December 2023?

Tampa Electric's Position: \$48,727,656. (Witness: Roche)

**<u>ISSUE 5</u>**: What are the conservation cost recovery factors for the period January 2023 through December 2023?

**Tampa Electric's Position**: For the period January 2023 through December 2023 the cost recovery factors for the rate design and cost allocation as put forth in Docket No. 20210034-EI are as follows:

**ISSUE 6:** What should be the effective date of the new conservation cost recovery factors for billing purposes?

**Tampa Electric's Position**: The factors should be effective beginning with the specified conservation cost recovery cycle and thereafter for the period January 2023 through December 2023. Billing cycles may start before January 1, 2023, and the last cycle may be read after December 31, 2023, so that each customer is billed for 12 months regardless of when the factor became effective. (Witness: Roche)

**<u>ISSUE 7:</u>** Should the Commission approve revised tariffs reflecting the energy conservation cost recovery amounts and energy conservation cost recovery factors determined to be appropriate in this proceeding?

<u>**Tampa Electric's Position</u>**: Yes. The Commission should approve revised tariffs reflecting the energy conservation cost recovery factors determined to be appropriate in this proceeding. (Witness: Roche)</u>

#### COMPANY SPECIFIC CONSERVATION COST RECOVERY ISSUES

**ISSUE 8:** What is the Contracted Credit Value for the GSLM-2 and GSLM-3 rate riders for Tampa Electric Company for the period January 2023 through December 2023?

<u>**Tampa Electric's Position</u></u>: In accordance with Order No. PSC-2021-0423-S-EI, issued November 10, 2021 in Docket No. 202100034, the Contracted Credit Value by Voltage Level for the forthcoming cost recovery period, January 2023 through December 2023, for the GSLM-2 and GSLM-3 rate riders will be:</u>**

**ISSUE 9**: What are the residential Price Responsive Load Management (RSVP-1) rate tiers for Tampa Electric Company for the period January 2023 through December 2023?

<u>**Tampa Electric's Position</u></u>: For the period January 2023 through December 2023, the Residential Price Responsive Load Management (RSVP-1) rates are as follows:</u>**

Note 1: At the time required for this filing, the company has not completed the analysis to determine all of the other clause factors that are utilized to calculate and establish the RSVP-1 rates for the January through December 2023 period. The company will file with the Commission the proposed RSVP-1 rates for Tampa Electric's Price Responsive Load Management program based upon the company's 2023 residential base rates and the 2023 projected clause amounts for ECCR, Fuel and Purchased Power Cost Recovery, Capacity Cost Recovery and the Environmental Cost Recovery as soon as the remaining clause factors are finalized. The company is projecting to have this analysis completed and filed with the Commission by September 15, 2022.

**ISSUE 10**: Should this docket be closed.

**Tampa Electric's Position**: Yes, Docket No. 20220002-EG should be closed once the Commission's decisions on all of the issues in the docket have become final and the Commission has concluded that the docket has otherwise met the requirements for closure.
