**JOINT REPORT OF PEOPLES GAS SYSTEM AND
THE CITY OF JACKSONVILLE BEACH D/8/A BEACHES ENERGY
SERVICES ON STATUS OF TERRITORIAL BOUNDARY AGREEMENT**

In Order No. PSC-14-0109-PAA-GU issued on February 24, 2014, in Docket No. 130256-GU, the Florida Public Service Commission ("Commission") approved the territorial agreement hereinafter (the "Agreement") entered into by Peoples Gas System, a division of Tampa Electric Company ("PGS") and the City of Jacksonville Beach, a municipality organized under the laws of the State of Florida d/b/a Beaches Energy Services ("Beaches Energy"). Section 3.6 of the Agreement calls for a meeting of the parties prior to the second anniversary of the effective date of the Agreement (and no more than every fifth anniversary thereafter), and to a joint report on the status of the Agreement to be submitted to the Commission following such meetings.

By way of the instant report, PGS and Beaches advise the Commission that (i) the Agreement remains in full force and effect, (ii) no modifications have been proposed in the terms of the Agreement; and (iii) no disputes between the parties have arisen concerning the provisions of the Agreement.

The parties will advise the Commission to the extent any changes to the Agreement are proposed and will petition the Commission to resolve any disputes which may arise with respect to the provisions of the Agreement if the parties are unable to resolve the same.
