Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light (FPL or Company) requests confidential classification of certain information filed in the above referenced docket, dated September 2, 2022.

The Company is claiming confidentiality of its filing under Section 366.093(3)(d), F.S., and Section 366.093(3)(e), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (d) “[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms,” and Subsection (e) “[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information.”

The information which FPL is claiming as confidential consists of pricing information for capacity purchases between FPL and various counterparties. The pricing information is regarded by both FPL and the counterparties as confidential. The negotiated pricing between FPL and the counterparties, is specific to the individual contracts and is not publicly known. FPL claims that disclosure of this information would negatively impact FPL’s ability to negotiate pricing favorable to its customers in future capacity contracts.

Staff has reviewed the Company’s documents and confidentiality request. In staff’s opinion, the information that is the subject of FPL’s request meets the criteria for confidentiality contained in 366.093(3)(d), F.S., and 366.093(3)(e), F.S.
